## FREEDOM AND HEALING SESSION DISCLOSURE & AGREEMENT STATEMENT

This freedom and healing session is a form of *biblical prayer ministry, not to be confused with professional counseling or other forms of psychotherapy or mental health services*. I am **not** a licensed professional counselor, psychologist or mental health professional. I am an ordained pastor/minister and/or a Harvest certified prayer ministry team leader or team member. I work with you only as you choose to work with me.

God has seen fit to work with and through The Harvest via the Freedom and Healing Center (FHC) in moving people toward freedom from spiritual problems that negatively impact their lives. It is, therefore, our expectation that He will help you through our time together. We cannot control God or promise what He will do. We can only promise that we will do our best to work with God for your good and His glory.

What usually happens in this type of ministry is that God brings a kind of “spurt” toward wholeness in each session. Often, additional work is necessary for a person to attain the complete freedom he/she and God desire. It may be advisable for the person to receive help from a professional counselor/psychologist as well. I strongly advise this, especially in dealing with mental illness, dysfunctional habits, marital conflicts, career counseling, etc. It is always advisable for the person to actively pursue spiritual disciplines such as church attendance, prayer, bible study and worship.

The information provided by the recipient during ministry sessions is strictly confidential and will only be shared with the supervising pastor over the FHC, director of the FHC, and the session team leader and team members. We are, however, **required by law** to report to appropriate persons two kinds of things\*

1. Any intent of a person to take harmful, dangerous, or criminal action against another person or against him/herself, or
2. Any act of child or elderly abuse or neglect.

**\* If it appears that such notification needs to be given, we intend to inform you first when necessary and appropriate.**

In order to provide the appropriate legal protection, each person must sign the following Statement of Release.

I hereby release The Harvest, the Freedom and Healing Center, and all of its leaders, volunteers, and agents from any liability should this ministry session not live up to my expectations. I assume all responsibility to seek any future care that I may need. I acknowledge and agree that I and or the FHC may terminate my participation at any time for any reason. This statement of release from liability shall remain in effect for this session as well as all future sessions.
